<u>Cherwell Cricket League Management Meeting</u> <u>Thursday 26th July 2018, 20.00hrs</u> Bicester North Oxford Cricket Club

Minutes of last meeting: Neilson Hinks had been omitted from the attendees list – this had been amended. Minutes agreed.

Matters arising:

It was noted that Rosie Beck had agreed to be the League's Welfare Officer. Clubs and the OCB had been notified. OCB had responded and saw this as a very positive move by the League.

Stopping of promotion of teams because of facilities

Aston Rowant need better off field facilities for 2^{nd} pitch. Letter sent July 1^{st} .

Bletchingdon – no response as yet

Westbury. There had been dialogue with JH since League letter sent. JH/BS visited today. 4 wickets could be played on for $1^{\rm st}$ team. Boundaries ok for these four wickets. Written assurances required from Westbury that only these four wickets would be used for $1^{\rm st}$ team and what efforts they are making to improve the quality of the square. It was accepted they were making some efforts but low marks may be a decision factor.

Correspondence:

OCB – acknowledgment of appointment of a CCL Welfare Officer.

Numerous Clubs – The League were copied into correspondence between numerous Clubs regarding changing the start time for games on July 7th. Clubs had complimented the League on this initiative.

OCA re Asif Shah (A) - This player had moved from Yarnton & Cowley (OCA) to Twyford. The player had been suspended from bowling in the OCA because of a suspect action. NH had contacted Twyford.

Minster Lovell CC (B) – Change of venue for their 2's game on 28th July. All parties informed by MLCC

Minster Lovell CC - (C) - letter from their Welfare Officer re CCL lower league cricket - specifically regionalization, win/lose cricket, neutral umpires in all divisions, less overs per game and later starts (2pm suggested). Items to be discussed at Forums

Minster Lovell CC – (D) – forfeiture of 3rds fixture v Dinton 3rds 28th July 2018

Buckingham CC - (E) request for change of venue to BNOCC because of ground conditions at North Marston. Agreed.

GM had sent email to Clubs that registrations closed before the matches this weekend

Finance:

LP reported.

The Finance report was circulated. Net assets are currently £38898.01 East Oxford paid £300 recently. LP to write re Sept 2nd deadline – failure could mean proposal that EOCC seek re-election at next AGM. Another 7 Clubs to be given the same warning by LP. **LP**

G.Murton - website fees etc of £568 approved BNOCC - meeting room hires of £375 approved

Email communication within Management Committee

Discussion over method of decision making within the Management Committee. Suggestions discussed - any Policy/Strategy items could wait till next meeting with one/two members in their area of responsibility to do research then debated at that next meeting. Day to Day issues (that could not wait for up to 30 days until the next meeting) - email debate over 5 days, then an email vote within 2 days, simple yes or no.

It was felt there should be a Registrations sub committee to help work load. BS to speak to GM **BS**

Disciplinary Reports

Horspath 2 v Oxford 2 July 14th 2018 . Incident regarding a 4ths player who was watching this game during a break in his game. Horspath had banned the player for the rest of the season. It was noted the League had not be made aware of this as Oxford CC had contacted Horspath direct.

Bledlow Ridge decision reached by disciplinary panel – IM felt umpire should have been supported. DMB to ask if Dom Pritchard has resigned as secretary.

Thame 3 v Tiddington 3 July 7^{th} 2018 – P.Wood (Tiddington), has this been actioned Bletchley 2 v Kingston Bagpuize 2 9^{th} June – P.Scholte , has this been actioned? **NH** Horley 1 v Cublington 1 July 21^{st} 2018 – C.Baines (Cublington) DMB/BS declared an interest. IM to take up.

Thame 3/4 . It was agreed Lord Williams School would not be acceptable next season unless there were dramatic improvements in ground and facilities. Possible change to Chinnor?. DMB to write to Thame.

JH reported email from Sam Hollingshead about game Eynsham 1 v Buckingham 3. BS to speak to Keith Cartwright of Brackley. – Brackley ground could not be used currently for safety reasons including very large cracks throughout the outfield.
